Any payment in respect of the Licensed Materials for a subsequent subscription period shall be deemed to constitute an extension of the License on the same terms herein unless otherwise agreed in writing.
4. The following conditions in respect of subscriptions to individual journals of the Publisher shall apply:
 - Subscriptions to journals outside the Licensed Materials (i.e. new journal launches and acquisitions) may be acquired at any time at a [% discount or fixed price].

The following are the **Standard Terms and Conditions** of in respect of a Licence to use Inderscience Publishers' online journals:

1. This Licence is made with Inderscience Enterprises Ltd, trading as Inderscience Publishers, of World Trade Center Building, 29 Route de Pre-Bois, (Case Postale 896) CR1215 Genève 15, Switzerland ("the Publisher")

2. In this Licence, the following terms shall have the following meanings: -

Authorised Users: If an academic or educational institution: current members of the faculty, staff, registered students of the Licensee, and alumni, authenticated by the Licensee and permitted to access the Secure Network from within the Library Premises or remotely from other places, and other persons permitted to use the Licensee's library services and access the Secure Network but only from designated computer terminals within the Library Premises; If a corporation, government department or agency or non-academic organisation: current employees and contractors of the Licensee, authenticated by the Licensee and permitted to access the Secure Network from within the Library Premises or remotely from other places.

Commercial Use: Use by or for the Licensee or an Authorised User for the purposes of monetary reward other than the recovery of direct costs incurred by the Licensee by means of sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Materials.

Course Packs: A collection or compilation of materials assembled by Authorised Users for use by students in a class for the purposes of instruction.

Electronic Reserve: Electronic copies of materials made and stored on the Secure Network by the Licensee for use by students in connection with specific courses of instruction offered to its students.

Fee: The Fee set out in this Licence.

Library Premises: The physical premises of the library or libraries operated by the Licensee as specified in this Licence.

Licensed Materials: The electronic material as set out in this Licence or in any duly agreed variation thereof.

Licensee: The party contracting with the Publisher, being a university, other educational institution or research organisation or a consortium of such bodies (in which case the Licensee shall be interpreted as including both the consortium and the members thereof).

Member Agreement: An agreement with the Publisher in which a member of a consortium being the Licensee agrees to participate in this Licence and be bound by the terms and conditions of this Licence as if it were a party to it jointly with the Licensee.

Secure Network: A network which is only accessible to Authorised Users and whose conduct is subject to regulation by the Licensee.

Server: The server, either the Publisher's server or a third party server designated by the Publisher, on which the Licensed Materials are mounted and may be accessed.

3. This Licence grants to the Licensee, subject to the payment of the Fee, the non-exclusive and non-transferable right to give Authorised Users online access to the Licensed Materials via a Secure Network for the purposes of research, teaching and private study.

4. The Licensee may:

- make such temporary local electronic copies by means of mirrored storage as are necessary solely to ensure efficient use by Authorised Users.
- allow Authorised Users to have access to the Licensed Materials from the Server via the Secure Network.
- provide Authorised Users with integrated access and an integrated author, article title, abstract and keyword index to the Licensed Material.
- provide single printed or electronic copies of single articles or items at the request of individual Authorised Users.
- display, download or print the Licensed Materials for internal information and marketing, for testing or for training Authorised Users or Groups of Authorised Users.

5. Authorised Users may

- search, view, retrieve and display the Licensed Materials.
- electronically save search results, individual articles or extracts of the Licensed Materials for personal use.
- print off search results or single copies of individual articles or extracts of the Licensed Materials
- distribute single copies of individual articles or extracts of the Licensed Materials in print or electronic form to other Authorised Users.
- use the Licensed Material to perform and engage in text mining and data mining activities for academic research on the Publisher's platform. Publisher reserves the right to change the method by which data and text mining and to introduce additional fees for data and text-mining upon reasonable notice

6. Nothing in this Licence shall in any way exclude, modify or affect any of the Licensee's rights under copyright law.

The Licensee may

- incorporate articles or items of the Licensed Materials in printed Course Packs and Electronic Reserve (including course packs in non-electronic non-print perceptible form, such as audio or Braille, to Authorised Users who are visually impaired).
- supply to another library (whether by post or fax or secure transmission), for the purposes of research or private study only, a single paper copy of an electronic original of an individual article or extract being part of the Licensed Materials.
- Each such item shall carry appropriate acknowledgement, listing title and author of the extract and the work, and the publisher. Copies of such items shall be deleted when no longer used for such purpose.

8. Neither the Licensee nor any Authorised User may, without the Publisher's prior written consent:

- remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Licensed Materials.

- make print or electronic copies of multiple extracts of the Licensed Materials other than for back-up copies permitted under clause 4.
- mount or distribute any part of the Licensed Material on any electronic network, including the Internet and the World Wide Web, other than the Secure Network.
- Use, print, resell or republish all or any part of the Licensed Materials for any Commercial Use.
- systematically or programmatically distribute the whole or any part of the Licensed Materials to anyone other than Authorised Users.
- publish, distribute or make available the Licensed Materials, works based on them or works which combine them with any other material, other than as permitted in this Licence.
- alter, abridge, adapt or modify the Licensed Materials, except to the extent necessary to make them perceptible on a computer screen or as otherwise permitted in this Licence, to Authorised Users. No alteration of the words or their order is permitted.

9. THE PUBLISHER WARRANTS THAT IT HAS USED ALL REASONABLE EFFORTS TO ENSURE THAT THE LICENSED MATERIALS DO NOT INFRINGE THE COPYRIGHT OR ANY OTHER PROPRIETARY OR INTELLECTUAL PROPERTY RIGHTS OF ANY PERSON. THE PUBLISHER SHALL INDEMNIFY AND HOLD THE LICENSEE HARMLESS FROM AND AGAINST ANY LOSS, DAMAGE, COSTS, LIABILITY AND EXPENSES (INCLUDING REASONABLE LEGAL AND PROFESSIONAL FEES) ARISING OUT OF ANY LEGAL ACTION TAKEN AGAINST THE LICENSEE CLAIMING INFRINGEMENT OF SUCH RIGHTS. THIS INDEMNITY SHALL SURVIVE THE TERMINATION OF THIS LICENCE FOR ANY REASON. THIS INDEMNITY SHALL NOT APPLY IF THE LICENSEE HAS AMENDED THE LICENSED MATERIALS IN ANY WAY NOT PERMITTED BY THIS LICENCE. THE PUBLISHER OTHERWISE MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF DESIGN, ACCURACY, MERCHANTABILITY OR FITNESS OF USE FOR A PARTICULAR PURPOSE. THE LICENSED MATERIALS ARE SUPPLIED 'AS IS'.

10. The Publisher shall:

- make the Licensed Materials available to the Licensee from the Server in the media format specified.
 - where practicable notify the Licensee in advance of any anticipated substantive specification change applicable to the Licensed Materials.
 - provide the Licensee and the Agent, within 30 days of the date of this Licence, with information sufficient to enable the Licensee to access the Licensed Material.
 - ensure that the Publisher's Server has adequate capacity to support the Licensee's usage at a level commensurate with prevailing standards of availability for information services of similar scope.
 - endeavour to make the Licensed Materials available to the Licensee and to Authorised Users without disruption save for routine maintenance and to restore access to them as soon as possible in the event of any interruption.
- reserve the right upon written notice to the Licensee to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish, or which on reasonable grounds it believes infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable or potentially infringing. If the withdrawal represents more than 10% of the journal or database content in which

it appeared, the Publisher shall refund to the Licensee that part of the Fee proportionate to the amount of material withdrawn and the un-expired portion of the subscription period.

- facilitate the collection and provision to the Licensee of usage data on the number of items, articles and abstracts downloaded by journal title on an annual basis for private internal use only, in a manner consistent with applicable privacy and data protection laws and as may be agreed between the parties from time to time. The Publisher will make available fully COUNTER-compliant usage statistics every three months (www.projectcounter.org).

11. UNDER NO CIRCUMSTANCES SHALL THE PUBLISHER BE LIABLE TO THE LICENSEE, OR ANY AUTHORISED USER OR ANY OTHER PERSON, FOR ANY SPECIAL, EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE INABILITY TO USE, OR THE USE OF, THE LICENSED MATERIALS. THE PUBLISHER'S AGGREGATE LIABILITY FOR ANY CLAIMS, LOSSES, OR DAMAGES ARISING OUT OF ANY BREACH OF THIS LICENCE SHALL IN NO CIRCUMSTANCES EXCEED THE FEE PAID BY LICENSEE UNDER THIS LICENCE IN RESPECT OF THE SUBSCRIPTION PERIOD DURING WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF OTHER REMEDIES. THE LICENSEE MAY BRING NO ACTION ARISING FROM THIS LICENCE MORE THAN 6 MONTHS AFTER THE CAUSE OF ACTION ARISES.

12. The Licensee shall:

- ensure that only Authorised Users are permitted access to the Licensed Materials.
- ensure that all Authorised Users are made aware of the importance of respecting the intellectual property rights in the Licensed Materials and undertake to abide by the terms and conditions of this Licence.
- inform the Publisher immediately upon becoming aware of any unauthorised use or other breach, and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence.
- issue passwords or other access information only to Authorised Users and use reasonable endeavours to ensure that the same are not divulged to any third party
- provide the Publisher, within 30 days of the date of this Licence, with information sufficient to enable the Publisher to provide access to the Licensed Material in accordance with its obligations, and notify the Publisher in advance if any significant change to such information takes effect.

13. SUBJECT TO APPLICABLE LAW, THE LICENSEE AGREES TO INDEMNIFY, DEFEND AND HOLD THE PUBLISHER HARMLESS FROM AND AGAINST ANY LOSS, DAMAGE, COSTS, LIABILITY AND EXPENSES (INCLUDING REASONABLE LEGAL AND PROFESSIONAL FEES) ARISING OUT OF ANY CLAIM OR LEGAL ACTION TAKEN AGAINST THE PUBLISHER RELATED TO ANY USE OF THE LICENSED MATERIALS BY THE LICENSEE OR AUTHORISED USERS OR ANY FAILURE BY THE LICENSEE TO PERFORM ITS OBLIGATIONS HEREUNDER. NOTHING IN THIS LICENCE SHALL MAKE THE LICENSEE LIABLE FOR BREACH OF THE TERMS OF THE LICENCE BY ANY AUTHORISED USER PROVIDED THAT THE LICENSEE DID NOT CAUSE, KNOWINGLY ASSIST OR CONDONE THE

CONTINUATION OF SUCH BREACH AFTER BECOMING AWARE OF AN ACTUAL BREACH HAVING OCCURRED.

14. The Licensee shall, in consideration for the rights granted under this Licence, pay the Fee within 30 days of signature and, if applicable, within 60 days of receipt of invoice relating to each subsequent subscription period. The Fee shall be exclusive of any sales, use, value added or similar taxes, for which the Licensee shall be solely responsible.

On termination of this Licence other than for cause as specified in this clause or other than breach by the Licensee, the Publisher shall provide continuing access for Authorised Users to that part of the Licensed Material which was published within the subscription period paid for by the Licensee, either from the Server, or by supplying electronic files to the Licensee.

In order to ensure that the Licensed Material is archived and preserved for future scholarship, the Publisher will archive the Licensed Material in at least one of the following archiving solutions, namely Portico, Clockss or Lockss or equivalent archiving solution and inform the Licensee in which of the archiving solutions the Licensed Material may be found.

In addition to automatic termination upon the expiry of the subscription period (unless renewed), this Licence shall be terminated:

if the Licensee defaults in making payment of the Fee and fails to remedy such default within 30 days of notification in writing by the Publisher.

if either party commits a material or persistent breach of any term of this Licence and fails to remedy the breach (if capable of remedy) within 30 days of notification in writing by the other party.

if either party becomes insolvent or becomes subject to receivership, liquidation or similar external administration.

On termination all rights and obligations of the parties automatically terminate except for obligations in respect of Licensed Materials to which access continues to be permitted. On termination by the Publisher for the Licensee's breach or default as specified in this clause, the Licensee shall immediately cease to distribute or make available the Licensed Materials to Authorised Users and shall return to the Publisher or destroy all Licensed Materials locally mounted. On termination of this Licence by the Licensee for cause, the Publisher shall forthwith repay the proportion of the Fee that represents the paid but un-expired part of the subscription period.

16. This Licence constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter of this Licence, whether oral or written. Alterations to this Licence are only valid if they are recorded in writing and signed by both parties.

17. This Licence may not be assigned or sub-contracted by either party to any other person or organisation, except as herein, without the prior written consent of the other party, which shall not unreasonably be withheld.

18. Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this Licence

or to such other address as notified by either party to the other as its address for service of notices, and shall be deemed to have been received within 14 days of posting.

19. Neither party's delay or failure to perform any provision of this Licence, as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this Licence.

20. The invalidity or un-enforceability of any provision of this Licence shall not affect the continuation or enforceability of the remainder of this Licence.

21. Either party's waiver, or failure to require performance by the other, of any provision of this Licence will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.

22. Unless otherwise provided in this Licence, this Licence shall be governed by and construed in accordance with laws of Switzerland, and the parties irrevocably agree that any dispute arising out of or in connection with this Licence will be subject to and within the jurisdiction of the Swiss courts.

The parties agree to use best efforts to resolve disputes in an informal manner, by decision of the Managing Director of the Publisher and the current Vice Chancellor or Vice President or equivalent of the Licensee. Where the parties agree that a dispute arising out of or in connection with this Licence would best be resolved by the decision of an expert, they will agree upon the nature of the expert required and together appoint a suitable expert by agreement.

Any person to whom a reference is made under this Clause 23 shall act as expert and not as an arbitrator and his decision (which shall be given by him in writing and shall state the reasons for his decision) shall be final and binding on the parties except in the case of manifest error or fraud. Each party shall provide the expert with such information and documentation as he may reasonably require for the purposes of his decision.

The costs of the expert shall be borne by the parties in such proportions as the expert may determine to be fair and reasonable in all circumstances or, if no determination is made by the expert, by the parties in equal proportion
