1. This Licence is made with Inderscience Enterprises Ltd, trading as Inderscience Publishers, of Rue de Pré-Bois 14, 1216 Cointrin-Geneva, Switzerland ("the Publisher")

2. In this Licence, the following terms shall have the following meanings: -

Authorised Users: If an academic or educational institution: current members of the faculty, staff, registered students of the Licensee, and alumni, authenticated by the Licensee and permitted to access the Secure Network from within the Library Premises or remotely from other places, and other persons permitted to use the Licensee's library services and access the Secure Network but only from designated computer terminals within the Library Premises; If a corporation, government department or agency or non-academic organisation: current employees and contractors of the Licensee, authenticated by the Licensee and permitted to access the Secure Network from within the Library Premises or remotely from other places.

- endeavour to make the Licensed Materials available to the Licensee and to Authorised Users without disruption save for routine maintenance and to restore access to them as soon as possible in the event of any interruption. reserve the right upon written notice to the Licensee to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish, or which on reasonable grounds it believes infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable or potentially infringing. if either party becomes insolvent or becomes subject to receivership, liquidation or similar external administration.

On termination all rights and obligations of the parties automatically terminate except for obligations in respect of Licensed Materials to which access continues to be permitted. On termination by the Publisher for the Licensee's breach or default as specified in this clause, the Licensee shall immediately cease to distribute or make available the Licensed Materials to Authorised Users and shall return to the Publisher or destroy all Licensed Materials locally mounted. 18. Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this Licence

or to such other address as notified by either party to the other as its address for service of notices, and shall be deemed to have been received within 14 days of posting.

19. Neither party's delay or failure to perform any provision of this Licence, as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this Licence.

20. The invalidity or un-enforceability of any provision of this Licence shall not affect the continuation or enforceability of the remainder of this Licence.

21. Either party's waiver, or failure to require performance by the other, of any provision of this Licence will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.

22. Unless otherwise provided in this Licence, this Licence shall be governed by and construed in accordance with laws of Switzerland, and the parties irrevocably agree that any dispute arising out of or in connection with this Licence will be subject to and within the jurisdiction of the Swiss courts.

The parties agree to use best efforts to resolve disputes in an informal manner, by decision of the Managing Director of the Publisher and the current Vice Chancellor or Vice President or equivalent of the Licensee. Where the parties agree that a dispute arising out of or in connection with this Licence would best be resolved by the decision of an expert, they will agree upon the nature of the expert required and together appoint a suitable expert by agreement.

Any person to whom a reference is made under this Clause 23 shall act as expert and not as an arbitrator and his decision (which shall be given by him in writing and shall state the reasons for his decision) shall be final and binding on the parties except in the case of manifest error or fraud.
